Item No. 3: To consider and decide on letter dated 15th November, 2018 received from Somaiya Vidyavihar, K.J. Somaiya College of Engineering, Mumbai regarding fixation of fees for academic years 2016-17 and 2017-18.

Read communication dated 21/3/2018, 6/11/2018, 15/11/2018 and 4/12/2018 received from K.J. Somaiya College of Engineering, Vidyavihar, Mumbai. The Institute is running B. Engineering and M. Engineering courses and has been conferred with autonomous status. On the basis of fee proposal submitted by the Institute fee Rs. 1,45,000/- for A.Y. 2015-16 was approved by Shikshan Shulka Samiti.

Since the college has been conferred with autonomous status, they were in dilama as to whether they were required to submit fees proposal to this Authority. For that purpose they made correspondence with this office. In the course of time this Authority considered the issue raised by the institute and few other similarly situated institutes. This Authority opined that the institutes with Autonomous status are required to submit fees proposal to this Authority.

This decision of the Authority was challenged by filling writ petition. After decision of the Hon'ble High Court SLP in the Supreme Court was filled. It was dismissed. In this process, the fee for A.Y. 2016-17 and 2017-18 remained to be decided, although, fee structure for the A.Y. 2018-19 has been decided by Fees Regulating Authority.

Since issue relates to the fee structure of 2016-17 and 2017-18, the Authority thought it necessary to hear the students of the institute. According to them the Institute collected from them Rs. 1,65,000/- for A.Y. 2016-17 and Rs. 1,78,000/- for A.Y. 2017-18, and for that they have no grievance. It is clarified by the Principal that students of 2017-18 batch is required to pay only Rs. 1,68,000/- at par with fees for A.Y. 2018-19.

The Balance Sheet and Income & Expenditure Accounts for the Financial Year 31/3/2016 considered for the determination of fees for A.Y. 2017-18. Based on the expenditure mentioned therein and applying the norms applicable for A.Y. 2017-18, the fees works out Rs. 1,78,000/- for B. Engineering and Rs. 1,70,000/- for M. Engineering course. Consequently for A.Y. 2016-17 B. Engineering fee is worked out at Rs. 1,65,000/- and for M. Engineering at Rs. 1,58,000/-. In view of the above, following course fees, being fees collected from the students is approved.

Item No. 4: In matter of hearing of review petition for A.Y. 2016-17 and 2017-18 field by K.J. Somaiya Institute of Engineering and Information Technology, Sion, Mumbai

On 17/11/2018 Dr. S.K. Ukarande, Principal and Mr. Faraz Kagalwala, CFO appeared before the Chairperson, Fees Regulating Authority and submitted purshis market X. It is stated that the Institute does not wants to pressed review application. Hence, Review application is disposed of as not pressed.

Item No. 5: To decide in the matter of Kai Ramrao Patil B.Sc. Nursing Mahavidyalaya, Udgir Dist- Latur.

From the Academic year 2015-16 the college is conducting B.Sc. Nursing course. In the year 2015-16 only 2 students were admitted. In 2016-17 there was no admission. In the Academic Year 2017-18 only 4 students were admitted.

As admitted by the college, no fee proposals for 2016-17 and 2017-18 were submitted

In the fee proposal for Academic Year 2018-19, submitted online, the staff position is: One K. Anita shown as teaching faculty. Her joining date is 25/7/2016. Salary paid to her is entered in the software at Rs. 60,60,000/- in cash. No TDS. One Bhagwan Laxmanrao Patil is shown as non teaching staff. His joining date is 2/9/2015. His salary is entered in the software at Rs. 55,44,000/- paid in cash. No TDS. Figures are apparently un realistic and liable to be rejected. It is strange that college is conducting B.Sc. Nursing course only one teaching staff.

On perusal of income and expenditure and balance sheet submitted before us for the year ended 31/3/2017 and balance sheet as on 31/3/2017 it is apparent that the financial statement suffers from graves deficiencies. Bank account itself is not appearing as Current Assets. Movable properties such as furnitures, computers, machinery, books do not appear in the balance sheet. These assets are essential for running institute. Considering such grave deficiencies, fin ancial statements for the year ended 31/3/2017, as produced before us are liable to be rejected or need not be considered for determination of fees.

Having regard to the state of affairs, location of college, manner in which it is run and conducting overall scenario, fee structure shall be as follows:-

Fees for the year 2016-17 : Rs. 35000/-

Fees for the year 2017-18 : Rs. 35,000/-

Fees for the year 2018-19 : **Rs. 50,000/-**

Item No. 6: To consider and decide on for payment Gateway Support & service for review application and technical support for Information Technology & Software Modification of Online fee approval process for academic year 2019-20.

Approved as proposed.

Item No. 7: Any other issue with the permission of the Chair.

i) To decide the fees for Rashtramata Jijau Nursing School, Nilanga, Latur regarding fee structure for A.Y. 2016-17 and 2017-18.

This relates to approval of fee structure of Rashtrmata Jijau Nursing School, Latur for academic year 2016-17 & 2017-18. The Institute did not submit fee proposal for the both academic years and therefore, vide resolution dated 27/3/2018 penalty according to law was imposed.

The fee structure for academic year 2018-19 is approved Rs. 80,000/-. On that basis and in absences of balance sheets, audit report of the relevant years, fee structure for A.Y. 2016-17 and 2017-18 shall be Rs. 50,000/- and Rs. 55,000/- respectively.

ii) In the matter of fees proposal submitted by Vedanta Institute of Academic Excellence Pvt. Ltd, Mumbai for A.Y. 2017-18.

The institute has started MBBS course in the A.Y. 2017-18 with intake capacity of 150. The Institute on its own collected adhoc fees of Rs. 14,00,000/-. The students were aggrieved by the quantum of fees. The Institute also filed writ petition in the Hon'ble High Court claiming that it has right to decide adhoc fees. The Hon'ble High Court directed this Authority to decide fees proposal of the Institute within 6 weeks from the date of its submission.

The Institute has submitted fresh online fees proposal on 14/11/2018 and its hard copy on 15/11/2018.

Since interest of the students are involved, their grievances already lodged with this Authority are required to be considered while approving fee structure. Therefore, representative of the students and Institute were asked to appear before this Authority. Parents of the students, appeared and submitted CD of the grievance. The Institute sought time.

Considering the availability of the Members matter is posted to 19/12/2018. The office to send copy of the student grievance to the Institute.
